In the event that there is no immediate needs in struggling Areas the money be contributed to hosting Area to hold the learning day and that Area would be determined from a Rotation much like the manner in which it is determined where RSC will be held.

Intent: To carry the message to still sick and suffering addicts in more remote Areas where there is not access to a NA meeting without a substantial drive.
